## **Re: Freedom of Information Act Request**

Dear Sir or Madam:

I am Lisa Goodgame, President of Indivisible Austin. I make this request for records held by the Department of the Treasury pursuant to the Freedom of Information Act, 5 U.S.C. 552(a).

I am requesting copies of documents from the Department of the Treasury's Office of Tax Policy (OTP) related to the Tax Cuts and Jobs Act of 2017. In particular, I request any and all documents that contain the following information:

- Projections, forecasts, and evaluations made by the OTP that estimate the revenue impact of the Tax Cuts and Jobs Act for the Austin, Texas Metropolitan Statistical Area (MSA).
- Projections, forecasts, and evaluations made by the OTP of expected changes to the Austin MSA's tax revenue as a result of the implementation of the Tax Cuts and Jobs Act.
- Projections, forecasts, and evaluations made by the OTP of the Austin MSA's expected overall economic performance as a result of the Tax Cuts and Jobs Act.

This request also includes, but is not limited to, records relied on by the OTP to make these projections and records reflecting communications about them.


